Notice of Withdrawal

1. A full calendar month's written notice is required should you wish to withdraw your child from the School. Such notice must be submitted in writing to the School's administration office and must clearly state the intended date of the learner's final day of attendance.
2. All outstanding fees must be settled in full prior to the child's departure.
3. Failure to provide the required written notice will result in a charge equivalent to one month's tuition fee in lieu of notice, which shall become immediately payable upon withdrawal.

Attendance and School Fees Policy

a. **Attendance for Children Under Three Years of Age**

Children younger than three years may attend the school on a flexible attendance schedule. The School recommends that attendance occur on consecutive days within the week to provide consistency, support social development, and promote a stable learning routine for the child.

b. **Attendance for Children Aged Three Years and Older**

Children aged three years and older are required to attend the School on a structured, full-time basis, being five days per week. Regular and consistent attendance is an essential component of the school's developmental and educational programme.

c. **Calculation and Payment of School Fees**

School fees are calculated in advance based on the number of school days selected in this contract. School fees for children attending less than five days a month may vary month to month based on the number of selected days in a month. Example some months have more M/T/W/T/F in a month.

d. **School Fees Payment**

School Fees are payable strictly in advance by the last working day of each month. School Fees should reflect in the Jozi Jammers bank account by no later than the 02nd of each month. (Example: January school fees must be paid by 31 December, reflecting in the school's bank account by 02 January). A penalty fee of R100 will be charged for fees received after the 07th of each month. Failure to pay fees will result in the immediate suspension of your child.

e. **School Fees are Payable During Absences and School Closures**

Fees remain payable in full regardless of a child's absence for any reason, including but not limited to illness, family holidays, public holidays, government-declared holidays, or any unforeseen circumstances that may require the temporary closure of the School (including events of natural disasters). This condition is consistent with standard practice in the education sector and ensures that the School can continue to meet its operational and staffing obligations. In accordance with the Consumer Protection Act, parents/guardians are encouraged to request clarification on this clause prior to signing this Agreement.

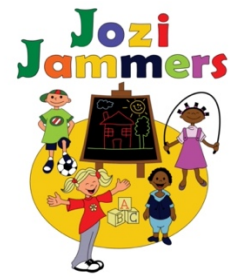

DAILY SCHEDULE

06:30 – 07:30	School Opens. Free play, imaginative play. Puzzles. This allows the children to explore and familiarize themselves with their surroundings and interact with their class friends in a more relaxed environment. It helps them transition into the days more structured activities with ease.
07:30 – 08:00	Breakfast
08:00 – 08:30	Classes start. Bible story, memory verse, worship. Sound Biblical principles are the focus point (core) of all our lessons. Our children are taught how to apply Biblical principles to real life situations. They learn memory verses which are age appropriate and Christian songs.
08:30 – 09:00	Theme Based Discussion. Perceptual Development. Language Development. Each week the children are introduced to a new theme which they explore for the week e.g. The Ocean; Wildlife etc. During this ring time they also learn to identify their letters, numbers, shapes and colours.
09:00 – 09:30	Exercises. Gross motor skills that are age appropriate. This assists the children to reach their age-appropriate milestones e.g. skipping, crossing the midline etc.
09:30 – 10:00	Toilet routine, wash hands. Snack time. The children are taught to routinely wash hands and a hygienic toilet routine is encouraged. This is done a few times during the day. Our teachers and assistants are also equipped to potty train.
10:00 – 11:00	Outdoor free play. Social skills. Language development. Gross motor development. We have a very large playground because we believe that outdoor play is one of the most important aspects of a child’s all-round development. The children are encouraged to explore the playground. In doing so they learn to respect their friends by taking turns and sharing, they learn how to communicate with each other in a more social setting and all this while having fun. Our teachers and helpers oversee playtime to ensure safety and encourage positive behaviour.
11:00 – 12:00	Craft/creative activities, painting, cutting. Craft related to the theme. Fine motor skills (puzzles, threading, beading, peg boards) The children do age-appropriate crafts and learn skills with instructions and assistance.
12:00 – 12:30	Lunch time.
12:30 – 13:00	Half Day ends. Children that are enrolled for ¾ day and full day play outdoors until 1pm.
13:00 – 14:30	After care nap time. End of ¾ day. Nap time is encouraged for nursery school level as this allows the children to absorb the information learnt in the day and they have enough energy to carry them through the remainder of the day. The children that do not nap are given activities that allow them to relax like free play with Legos.
14:30 – 17:30	After care arts and crafts. Snacks at 2pm, 4pm & 5pm. Full day ends at 5.30pm. Our after-care class has a more relaxed approach to learning with fun activities that include baking, messy play and fun crafts.

RULES AND REGULATIONS

Welcome to Jozi Jammers Nursery School. Jozi Jammers exists as a nursery school to transform the lives of children and parents in our community with Biblical values and to provide nursery school education for children. We believe that each child is a blessing from God and our passion is to see children grow into what God has ordained them to be by teaching them the truth of the Bible.

The rules and regulations have been put in place in the best interest of our children. It is important that you read and understand our Rules and Regulations. Please ensure that every effort is made to adhere to these rules and regulations. If there is any point that you do not fully understand, please ask for an explanation before signing.

Application Form

1. A separate application must be completed for each child.
2. Upon submission of the enrolment form, signature of these rules and regulations, payment of the registration fee, the child will be enrolled at the school for an indefinite period of time until terminated with due notice.

Communication

3. WhatsApp Group: Class communication is sent through a class WhatsApp Group. Each teacher administrates their class WhatsApp group. This group is ONLY for teacher communication and reminders. Please do not use this for ANY other communication. If you wish to chat to the teacher, please message her privately or arrange a time with the secretary to meet with the teacher/principal.
4. Newsletters: These are sent monthly via WhatsApp. Please ensure that these are read as they contain important information about the school and events.
5. Please respect teachers time during school hours. If there is an emergency that requires immediate attention, you may call the office or send a WhatsApp to the school. The contact numbers are below.
6. Parent-Teacher meetings are held mid-year to discuss your child's progress. If additional meetings are required, please arrange with the office. However, should we notice anything that needs to be brought to your attention we will do this soonest.
7. Please notify the school of any changes to your contact numbers, address, e-mail address. It is extremely important to keep this up to date in case of emergencies.
8. Please direct your emails to the specific areas:

Notice of leaving

9. ONE calendar months' notice in writing of the proposed removal of your child from the school must be given and the necessary outstanding fees must be paid. If not received in writing, the FEE FOR THE MONTH IN LIEU of such notices WILL BE CHARGED.

Time

10. School hours are from:
 - a. 06:30 to 17:30 (Full Day)
 - b. 06:30 to 14:30 (Three Quarter Day)
 - c. 06:30 to 12:30 (Half Day)
11. Office hours are from 7am – 1pm on weekdays only.
12. The School Programme starts promptly at 08h00. These times must be strictly adhered to, to benefit from the full programme.
13. Jozi Jammers Nursery School corresponds with the government school calendar for Gauteng throughout the year. School is opened throughout the year besides the December break.

Meals

14. The school provides all meals throughout the school day. Please let the school know of any allergies or foods your child cannot eat.
15. Please do not send any food and drinks from home.

Collection of the Child

16. We will only allow the child to go home with the parents/legal guardian, or with an adult person who is in possession of a written authorization, signed by the parent/legal guardian, which purports to be a document authorising the bearer to fetch the child. Proper identification must be provided by the adult. Parents are to make prior arrangements in writing via email, when anyone other than themselves collect the child.
17. Children who are enrolled in the Half Day and Three-Quarter Day programme and are collected after 12:30 and 14:30 respectively will be enrolled in aftercare and a daily aftercare rate will be added to your invoice.
18. Children collected after 17:30 will incur a fine of R100 for every 15 minutes thereafter.
19. Please be considerate as our staff have families to attend to as well as make use of public transport.
20. If you use a transport company, please ensure that your driver is aware of your child's registered time at school.

Fees

21. Fees can be paid via a card facility at reception or EFT.
22. A non – refundable Registration Fee is payable on acceptance of application.
23. Annual Stationery fees are payable upon registration.
24. School Fees are payable strictly in **advance** by the last working day of each month. Fees should reflect in the Jozi Jammers bank account by the 2nd of the respective month. (Example January 2026 fees must be paid by 31 December 2025, reflecting in the school's bank account by 02 January 2026)
25. Failure to pay the school fees will result in the immediate suspension of your child.
26. A penalty fee of R100 will be charged for fees received after the 07th of each month.
27. School fees are payable for, irrespective of school holidays, public holidays and government declared holidays.
28. No reduction in school fees will be made whenever your child is absent from Nursery School.
29. The school cannot be held liable for any refund of fees in case of forced closure as a result of but not limited to a natural disaster, riot, war, health pandemic etc.

Sick

30. Under the Medicine and Related Substance Amendment Act of 2015, we are not permitted to dispense any medicine. Children who are sick and need medication are required to stay home until they are well enough to return to school or at least be kept at home for the first two days of treatment.
31. The school does not encourage your child to attend school while being ill.
32. The school does not encourage your child, when on antibiotics to attend school.
33. According to Health Regulations, we request that children with the following symptoms not be sent to school. Children who develop the following symptoms at school will be sent home immediately in order to prevent the spread of illnesses. Your assistance with collecting the children as soon as possible will be appreciated.
 - a) A fever over 37.8°C orally or 37.2°C under the arm.
 - b) Signs of a newly developing cold or uncontrollable coughing, diarrhoea, nausea or vomiting.
 - c) Unusual or unexplained loss of appetite, fatigue, irritability or headache.
 - d) Any discharge or drainage from eyes, nose, ears or open sores.
 - e) Any other known contagious infection.
34. Children suffering from an infectious condition such as but not limited to chicken pox, coughs, pink eye, colds, lice, ring worms etc. may only return to school with a doctor's note saying that the child is well enough to attend school.

Medication

35. If medication in the event of life-threatening situations such as EpiPen's, asthma pumps, diabetic medication is to be kept at school it is the parent's responsibility to ensure the relevant staff are shown how to administer the medication and the medication has not exceeded its expiry date. A written letter must be provided to the school by the parent/legal guardian providing instructions for the medication. The school will not be held responsible for the incorrect administration of medication or medication that has exceeded its expiry date.

Clothes

36. A change of clothing to remain in the child's bag.
37. Children should be dressed in easy to manage everyday clothing and comfortable everyday shoes. The school encourages free play and children are not reprimanded for getting dirty.
38. A sunhat is compulsory for outside playtimes.
39. Sunblock should be applied before dropping off.
40. Please mark clearly all personal belongings.

What to Pack

41. Change of clothes (more than one set for potty training children)
42. Hat (one will be supplied by Jozi Jammers).
43. Nappies must be provided monthly/weekly. Please discuss this with your class teacher.
44. There is no need for water bottles. Each class has a water station with school cups.

Lost Property

45. The school will not be held liable for the loss of any unmarked shoes and clothing.
46. Shoes and clothing that go unclaimed for 2 or more months will be donated to our charity.

Annual and Term Requirements

47. Stationery and toiletry costs are payable annually.
48. This cost covers the requirements set out by the class teacher of your child's specific age group.

Safety in the Parking Area

- 49. Parents are not allowed to drive down the school driveway to drop off or pick up your child/children.
- 50. Parent must park at the top of the driveway and walk down.
- 51. Parents will be permitted to use the driveway only on rainy days.
- 52. Children are not permitted to walk down the driveway unsupervised.
- 53. Hold your child's hands and do not let them run between cars.
- 54. It is your responsibility to ensure that you/your transport company has a car seat or a booster seat while travelling.

Extra Murals

- 55. Jozi Jammers offers a range of extra murals. These are optional, and payment is separate to school fees. Please pay the extra murals directly. No cash is to be sent to school as we will not be held liable for any loss thereof.

Baker – Baker

- 56. Each child will have a turn to be a baker-baker, your child will dress up like a baker and offer their yummy treats to the class. You will be notified in advance that your child's turn is coming up, please send a yummy treat for the class on that day.

Celebrations

- 57. Birthdays: your child can enjoy a small party on their birthday. Please make arrangements with their class teacher.
- 58. We have various celebration days throughout the year, where the children dress up, be a bit silly and have fun. You will be notified in advance via WhatsApp messages of these days but please make every effort to allow your child to participate.

Fundraising

- 59. A Market Day is held once a month in which each class gets a turn to sell healthy treats to the rest of the school. If it is not your child's turn to sell goods, please send R5 with your child to buy a treat on these days. This will be communicated to you via WhatsApp groups.
- 60. There are various fundraising events throughout the year, please make every effort to participate and support this. Jozi Jammers runs on a "not for profit" basis and whatever money is raised goes towards the maintenance of the school and to cover additional running costs.

Parents Right to Custody

- 61. Should the Parents right to custody of the Child become limited in any manner whatsoever, whether by way of divorce or otherwise, the onus rests on the parent who retains legal custody of the child to supply the school with a court order to such effect. The school will not be held responsible for rendering possession of the child to a parent who may no longer be entitled there-to if proper notification is not provided timeously.
- 62. The school must be provided with a certified copy of custody and visitation court order in order to enforce this.

Other

- 63. Please do not allow your child to bring any toys to school.
- 64. Please notify the school if your child is absent for the day.
- 65. Preschools are governed by the Department of Education. When reading any Government Gazettes, please ensure that you are familiar with which Department and who it impacts.

Reservation of right to make rules

66. The School reserves the right to make, changes, alter or amend its rules, within reason, from time to time and the Parent agrees to abide by any such rule.

 - b. Signs of a developing cold or persistent/uncontrolled coughing, diarrhoea, nausea or vomiting
 - c. Unexpected or unexplained loss of appetite, extreme fatigue, irritability or headache
 - d. Any discharge or drainage from the eyes, nose or ears, or open sores
 - e. Any other known contagious infection
